## PAYMENT

ILLUMINATED ESCAPES INC hereby leases to the VESSEL RENTER, and the VESSEL RENTER hereby leases from ILLUMINATED ESCAPES INC one storage slot for a monthly fee of [\$95.00 + HST] and a rate of [\$375.00 +HST] per season, due upfront and by June 1st of each season. They amount is and payable via the online booking calendar, credit or debit, or Interac E-Transfer to [info@illuminatedescapes.com](mailto:info@illuminatedescapes.com) ILLUMINATED ESCAPES INC reserves the right to change the rate per season, at its sole discretion, for any subsequent year of storage.

## CONTACT INFORMATION AND EMERGENCY CONTACT

The VESSEL RENTER agrees to provide updated contact information to ILLUMINATED ESCAPES INC and designate an emergency contact person for their vessel and equipment.

## INTERPRETATION AND SEVERABILITY

This agreement is intended to be broad and inclusive within the limits of the law. If any part is found invalid, the rest remains in effect to the fullest extent permitted

## SAFETY ORIENTATION

The VESSEL RENTER must attend a safety orientation session before storing their vessel at ILLUMINATED ESCAPES INC's storage facilities.

## HOURS OF OPERATION

The storage container will be opened daily at 11:00AM and closed 30 minutes after sunset, weather permitting, for the duration of the season. ILLUMINATED ESCAPES INC will ensure that the storage facility is open during the specified hours of operation. However, access may be closed due to inclement weather, location closure, container maintenance or safety reasons. VESSEL RENTERS are advised to check the weather forecasts and call 1-855 222 6214 to confirm with ILLUMINATED ESCAPES INC whether the storage facility will be open or closed.



# ILLUMINATED ESCAPES INC VESSEL STORAGE AGREEMENT

## VESSEL STORAGE LIMITATIONS

- Storage is for non-commercial, personal-use kayak or SUP craft only and is nontransferable.
- The VESSEL RENTER is responsible for guaranteeing that their vessel is in good repair, functioning properly, and cleaned of all water/debris before being placed in the assigned storage slot.
- No vessel shall be stored in a manner that endangers the storage facility, other vessels, or equipment, or prevents the kiosk container doors from closing properly.
- Fins must be removed from paddleboards before storing.
- No vessel or any other equipment shall be placed or overhang beyond the assigned storage spot.
- No wet items such as PFD's, clothing, equipment shall be stored inside the container.
- When not in use, vessels must be securely locked to the assigned storage spot.
- VESSEL RENTERS and their guests must conduct themselves respectfully at all times while using the storage facilities.
- VESSEL RENTERS and their guests must comply with all applicable laws and regulations and refrain from using stored vessels while under the influence of drugs or alcohol.
- Vessels must be removed from the storage container by 9:00am EST on the final day of the storage season. Failure to do so may result in the vessel being considered abandoned and disposed of by ILLUMINATED ESCAPES INC.
- ILLUMINATED ESCAPES INC may amend these VESSEL STORAGE LIMITATIONS by email to the VESSEL RENTER and by posting updates on the [www.Illuminatedescapes.com](http://www.Illuminatedescapes.com) website.
- The VESSEL RENTER agrees to review and comply with any amended versions from the effective date set by ILLUMINATED ESCAPES INC.

## WAIVER, RELEASE, INDEMNITY AGREEMENT & ACCEPTANCE OF RISK AND LIABILITY

I, the undersigned VESSEL RENTER, acknowledge that ILLUMINATED ESCAPES INC is granting me the privilege of storing my vessel. In consideration of this privilege, I agree to the following for myself, my guests, and any representatives.

### RELEASE

I release ILLUMINATED ESCAPES INC and its affiliates from liability for any loss, theft, or damage, as well as injury or property damage, whether due to negligence or otherwise. **INDEMNIFICATION** I agree to indemnify ILLUMINATED ESCAPES INC against any loss, liability, or cost resulting from storing or using my vessel on their premises.

## EARLY TERMINATION POLICY

If terminated, ILLUMINATED ESCAPES INC will refund any unused portion of the seasonal rate, and the VESSEL RENTER must remove their vessel and equipment within 48 hours of the notice.
